Investment Objective

The Balkerne Asset Management Income ISA (Individual Savings Account) is an activelymanaged portfolio of 30 to 45 holdings, with a minimum cash holding of 3% and has the Investment Objective to provide long-term capital and income appreciation with a Lower than Medium Risk Profile.

Suitability

This portfolio is particularly suited to clients who wish to retain a degree of safety in their portfolio, but are also looking for a higher rate of investment return than is associated with prioritising capital preservation. Investors understand that the value of their investments, and the income from them, are not guaranteed and may rise and fall to a greater extent than with a 'Conservative' portfolio.

Investment Policy

To achieve the investment objective by investing principally, but not exclusively, in fixedinterest/bond and cash investments (minimum weighting 33%), UK blue-chip equities (minimum weighting 20%) and, as appropriate, property, international and specialist stocks through collective investments and alternative investments (such as absolute return funds or multi-asset strategy funds).

Valuations & Reporting

Quarterly valuations are issued as at 31 March, 30 June, 30 September and 31 December of each year. Included with the valuation is a schedule of income received for the period.

Lead Manager's Commentary as at 30.06.24

The Income ISA returned +1.9% over the second quarter of 2024 and a pleasing +11.9% over the last 12 months.

Performance was driven by both asset allocation and stock selection. We hold an overweighting in fixed-interest/ corporate bonds. Our best performing funds over the quarter being Royal London Corporate Bond Fund and Rathbone Ethical Bond Fund.

The Income ISA holds a neutral weighting to equities. Outperformers in the quarter included Anglo American, AstraZeneca, Softcat, Barclays Bank, Blackrock World Mining Trust and 3i Group Trust. Underperformers included GSK, Spirent Communications and Edinburgh Worldwide Trust.

We are overweight alternative assets. Our best performing commercial property holding was Workspace Group REIT and our best performing alternative was Bluefield Solar Income Fund.

No new holdings were established in the quarter. One position was exited in the quarter Artemis Positive Future Fund.

The Income ISA is positioned to benefit from the recovery in the western world and take advantage of lower interest rates. We favour income producing assets, with some inflation protection and a balanced exposure to UK & International equities and corporate debt, whilst retaining a minimal weighting to direct sovereign debt.
